The Alliance has been working on many projects over the past year, and coming to fruition is the introduction of a Business Advisory Committee.

The Committee mandate will be to advise the 39/20 Alliance Board on matters that pertain to economic development, business development, and growth opportunities for the member communities within the 39/20 Alliance, and is just one of the strategies of the 39/20 Alliance to promote economic development with the region.



Specifically, the Business Development Advisory Committee will advise 39/20 Alliance Board of Directors on issues that affect the business community regionally, highlight opportunities for business growth and enhancement and provide input into the priorities and strategic direction of the 39/20 Alliance.

The committee will be comprised of two members from each of the Alliance communities and will be appointed for a two year term, with the Chair being chosen annually from amongst the committee members.
